Make a Difference — Run for a Seat on the AFA Council!

Total of 11 seats open in this election including three newly created seats open for the first time. Some incumbents may not run again.

This is your chance

to make a concrete

and positive difference

in working conditions,

salaries, and benefits

for all faculty!

As you probably know, the AFA Executive Council is the decision-making body of the AFA. The 19 faculty members who are elected (13 regular and 6 adjunct) represent the Unit A faculty on contract issues. Those 19 Council seats include three entirely new representative

positions (two regular and one adjunct), which were created when the AFA Bylaws were revised in May 2008. Those three new seats are now open for election this spring.

Inaddition, the terms for eight Council incumbents will expire at the end of Summer 2009. These incumbents include six regular faculty representatives: John Daly, Counseling; Cheryl Dunn, College Skills; Michael Meese, Administration of

Justice; Johanna James, Computer Studies; Warren Ruud, Mathematics; and Greg Sheldon, Counseling; and two adjunct faculty representatives: Lynn Harenberg-Miller, Communication Studies; and Mike Starkey, Computer Studies. Some incumbents may not be running for re-election.

The total number of seats to be filled is eleven (eight regular and three adjunct). An election will be held in February. Elected representatives will serve a two-year term, which will start at the beginning of the Fall 2009 semester. We encourage every interested AFA member to run for a seat on the Council. This is your chance to make a concrete and positive difference in working conditions, salaries, and benefits for all faculty!

Duties of Council Members

Executive Council members are expected to:

• attend two Council meetings per month, which are typically scheduled on the second and fourth Wednesdays of the month from 3:00 to 5:00 p.m.,

on the Santa Rosa campus;

- provide consultation to and representation for both regular and adjunct faculty;
- maintain confidentiality on designated issues; and
- represent AFA on at least one District-wide or AFA Standing Committee.

Payment for Adjunct Representatives

In accordance with the Adjunct Faculty District

Activities Fund guidelines, adjunct faculty serving as representatives on the Executive Council will receive compensation based on the number of meetings scheduled each semester, at their Base Hourly rate using their current step and column placement.

Eligibility and Nomination Procedure

According to the AFA Bylaws, a candidate for the Executive Council must have been an AFA member continuously for the past five months in order to be eligible to run. All interested candidates need to file a *Nomination Form* with the AFA office, along with a brief statement of no more than 250 words to be included on the ballot. (cont. on reverse)

Voting

Starting on Thursday, February 5, ballots will be distributed to campus mailboxes of regular faculty

members of AFA and mailed to home addresses of adjunct faculty members of AFA. Ballots will be due back to AFA by 5:00 p.m., Tuesday, February 24. **Only current AFA members are eligible to vote in the election.** Regular faculty vote for the regular faculty representatives, and adjunct faculty vote for the adjunct faculty representatives. Election results will be announced in an *AFA Update*.

The Council will elect AFA Officers and Negotiators for the 2009-10 year at the Council meeting on March 25.
