## **MEMBER CONCERNS WITHIN AFA'S PURVIEW**

1. A Councilor raised a concern brought forward by several faculty members. For background, a few years ago a widespread cheating scandal at Harvard was disclosed. In that case, Harvard administrators looked through faculty email messages to learn who had leaked the story to the media. We need to ensure that we have policies and contract language protecting faculty from this type of invasion of privacy. As the result of a recent situation here at SRJC, faculty and administrator email messages were reviewed without notifying the people ahead of time. The Councilor believes that this was done due to bad judgment rather than criminal intent, but it points to the need for policy and contract language to guide the process in the future. Sean responded that SRJC Policy 2.13 (https://go.boarddocs.com/ca/santarosa/Board.nsf/Public?open=&amp%25252525253Bid=policies#) covers privacy rights with regard to email. There is also strong privacy language in our recent Side Letter Agreements (see http://www.afa-srjc.org/mou.shtml).

• Sean explained that nominations were opened at our last meeting. He asked if there were any nominations for this committee seat. There being none, this position will remain open until filled.

#### **OTHER REPORTS**

- 1. **President's Report.** Sean reported briefly on the following items:
  - We have been very busy in negotiations. We finished the spring semester Side Letter Agreement and have negotiated several special assignments that will assist in the equity work on campus (Queer Resource Center, IGNITE, Black & Ethic Studies lead faculty). We will also be protecting faculty rights and negotiating the new Senate special assignments.
  - He gave a report to the Board last night with a positive tone:
    - He expressed thanks for all who have worked hard and persevered through the very difficult situation since last March.
    - He expressed appreciation for the BSU and BLAC for challenging the College to make longoverdue changes. AFA has learned a lot from our affiliation with North Bay Jobs with Justice in their equity work; equity work is the essence of union work.
    - AFA has been involved in the PRT visits from ACCJC. The PRT team has two goals: to assist in the
      reformation of SRJC's shared governance system; and to assist in the development of an
      enrollment plan. AFA has strong interests in both of these goals and will be watching this process
      closely to make sure faculty and student needs are met. A committee composed of members from
      each of the impacted constituent groups is now developing broad terms for moving forward on the
      two goals.
    - He praised the Board for making the hard decision of approving a project labor agreement for the new science building to ensure that all the workers will have union rights. It was a controversial decision, and he expressed appreciation to them for their courage.
